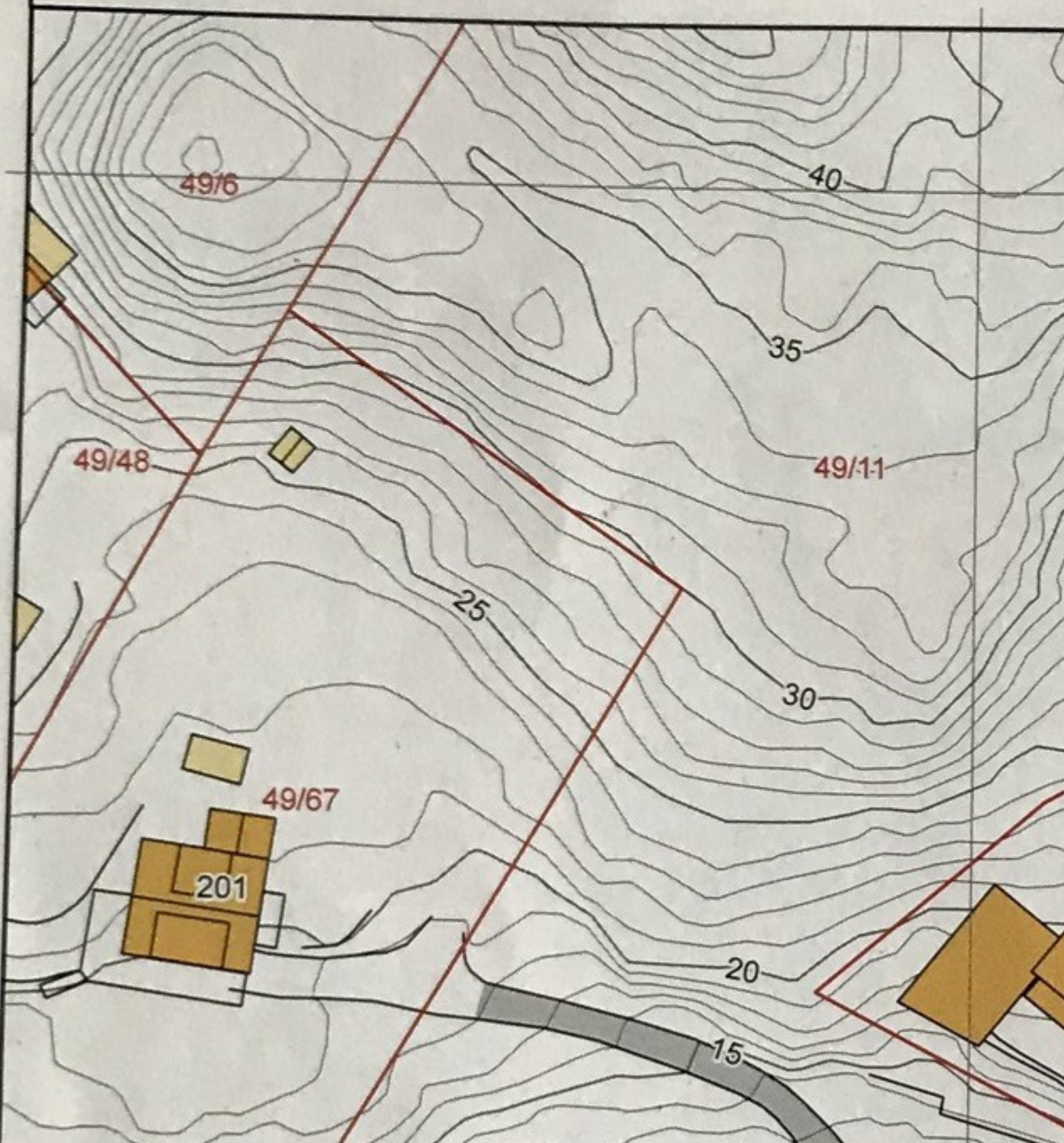
Can you help us ? Can you explain something what we should do ?

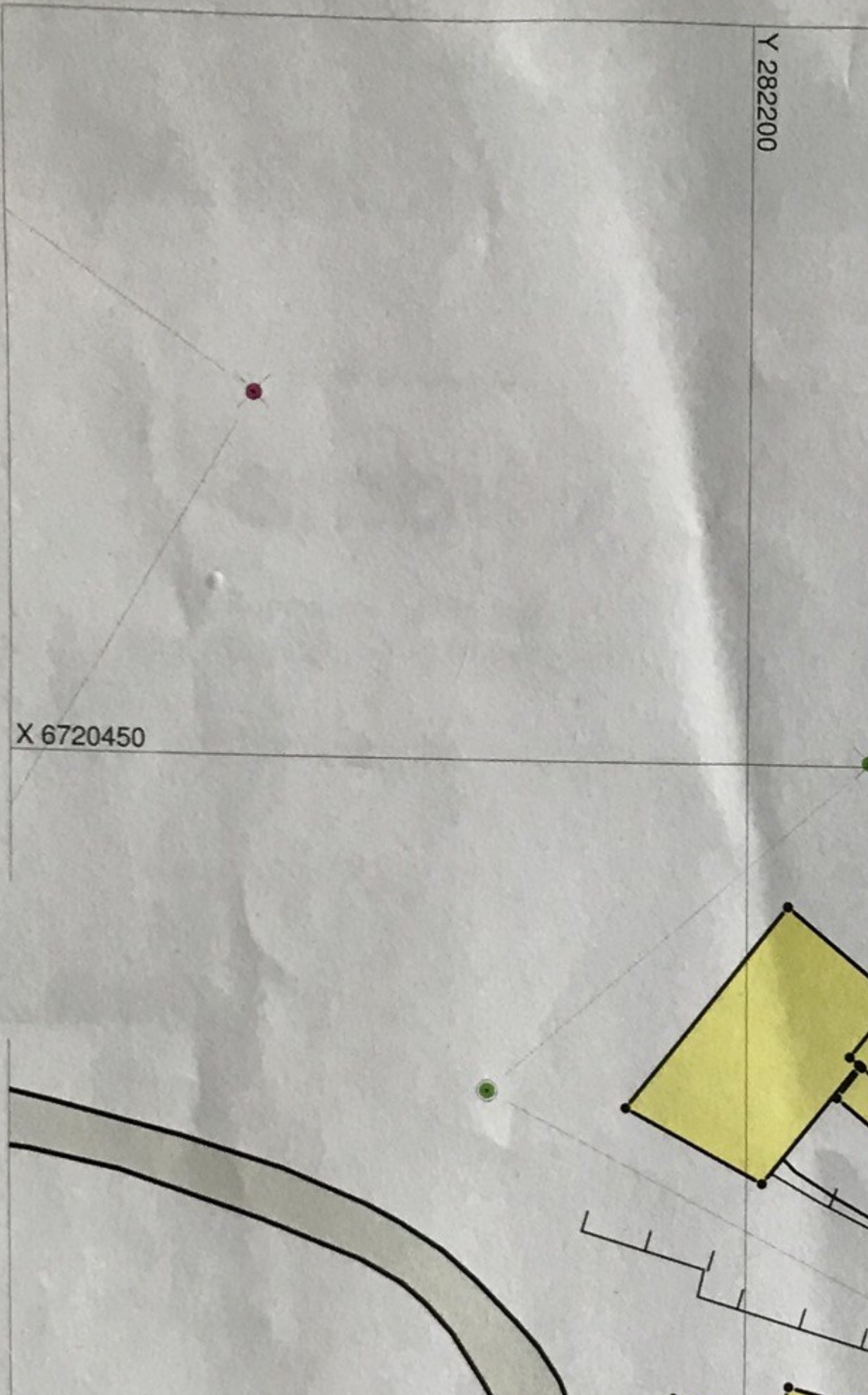

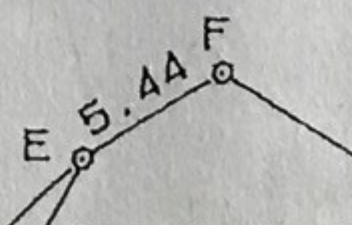
